





5.	<p>A complete set of Bidding Documents may be acquired by interested Bidders or his duly authorized representative on <b>October 4, 2024</b> to <b>October 23, 2024</b> from given address below and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the <b>amount of Php5,000.00</b>. The Procuring Entity shall allow the bidder to present its proof of payment for the fees in person</p>
